

2023 IMPACT REPORT

FOREST RESILIENCE

- Engaged **4500+ volunteers in people-powered restoration across our five mini-oases** restoration demonstration sites, resulting in less than 5% invasive plant cover across 20 of the 33 acres.
- Concluded a year-long planning effort convening subject matter experts to help create a park-wide forest resilience framework alongside the National Park Service to protect forests for future generations. The full framework will be released in early 2024.
- Hosted **33 invasive removal events** as part of the second annual Rock Creek Weed Wrangle; 450 volunteers removed 257 bags of invasive plants and freed 39 trees from invasive vines.
- With **our advocacy**, Montgomery Parks increased its budget for invasive plant management, including important Rock Creek stream valley activities.

PARK PARTNERSHIP

- Received the prestigious **Hartzog Award** for outstanding innovation in engaging volunteers by the National Capital Region (NPS).
- Made strides toward **revitalizing the Carter Barron Amphitheater** by providing \$560,000 to the National Park Service for construction drawings, following the release of the schematic designs in early 2024.
- Honored Julia Washburn, retired Rock Creek Park Superintendent, at a spectacular Rock Creek Gala with **nearly 400 attendees**.
- Installed two new tribute benches in Rock Creek Park.

CONNECTING COMMUNITIES

- Grew the **Carter Barron Alliance to 656 members** in the first year! The Alliance is a network of arts, parks, historic preservation, philanthropic, and community groups working to help revitalize the iconic Carter Barron Amphitheater.
- Fostered inclusivity and connectedness through 8 free, virtual Race, History, and Rock Creek programs in partnership with the National Park Service, including discussions on women in Rock Creek leadership, the history of Reno City, and a Pride celebration.
- Strengthened community and park connections with **800+ residents through Summer In the Parks** fun at Carter Barron and Fort Slocum.
- Provided summer work experience to 20 students from schools in both DC and Montgomery County as part of the Rock Creek Conservation Corps (RC3) - DC crew members pictured below.



WATERSHED HEALTH

- As part of the annual Rock Creek Extreme Cleanup, convened **54 cleanup** events where nearly **850 volunteers removed 8,500 pounds of litter**.
- Coordinated 61 community science volunteers who served 400 volunteer hours throughout the Rock Creek watershed, collecting 226 samples for bacteria monitoring.
- Completed **7 years of the Downspout Disconnection** program ensuring reduced runoff into Rock Creek by:
 - educating 12,553 households
 - removing 3.7 acres of impervious rooftop from the combined sewer system
 - installing 281 rain barrels
